Distributions above the penalty free amount are subject to an 8% penalty in the first year. The penalty decreases by 1% in each subsequent year. The base penalty is modified by a Market Value Adjustment (MVA). The MVA is indexed to the U.S. Constant Maturity Treasury Rate. MYGA rates effective 9/21/2026.

Available in IA, IL, MD, MO, OH, PA, TX, WV & WI. All plans include a Living Benefit Rider. Rates subject to change. WCU honors a 45-day rate lock - must receive funds from transferring company within 45 days of receipt of app.
